DESCRIPTION & OBJECTIVES

This course explores the aesthetic, technical, and conceptual practices of image making with digital media within the context of contemporary art. Students will practice how to perceive and create interesting digital images with an emphasis on the experimental and conceptual.

Course topics are addressed through lectures, watching video films, demos, exercises, projects, and student presentations. Students are evaluated based on contributions to their electronic process work, presentations, critiques, and aesthetic, technical, and conceptual development in their digital image making practices. Key software covered includes Touchdesigner, Adobe Premier Pro, Photoshop, and Aftereffect.

Through in-class and formal assignments students will:

- Generate digital image utilizing software fundamentals in Touchdesigner, Premier Pro, Photoshop, and Aftereffect.
- Explore the old and new experimental videos and films
- Research methods of visual art-making practice and create own portfolio
- Learn the basic skill of digital camera
- Develop visual literacy and critical thinking skills through participating in critiques
- Learn about contemporary artists who work with digital imaging as part of their practice

TEXTBOOKS AND MATERIALS

All required texts will be available on Canvas. Students are required to register with LinkedIn Learning and have access to reliable internet, Adobe Creative Cloud, and Zoom.

A media storage device such as a 1TB Hard Drive is also recommended for class projects and work.

METHOD OF INSTRUCTION

This course will consist of in person class instruction, but will also feature one day a project where students have the choice between in person or from home work days; a detailed, and tentative schedule is provided in advance in order to specify which days will require students present in person. **On student choice days, if a student chooses to work from home, a progress image is due by the end of class for attendance.**

COURSE STRUCTURE

This course consists of lectures, demos, in-class exercises, research, and critiques. Students should expect to work a minimum of 5 hours weekly beyond class time. Weekly content is laid out in modules and each week also has a page with the weekly expectations. Activities and projects to turn in are located in assignments. Project sheets will be available in modules at the start of each unit.

Projects

1. VISUAL POETRY
2. ANTI WAR
3. HOMAGE
4. FINAL PROJECT

Critique

At the end of each project there will be a critique. **Students will submit the project and short statement on Canvas by 12:00 am the night before.** To prevent stealing works from Internet, **it is mandatory for students to explain which/how methods/tools are used for the outcome.** Students must present on the Critique Day. A portion of your attendance grade will come from your contributions in critique.

All projects will be graded via assignments on Canvas and will be available to see within two weeks of the due date. **This class doesn't have regular assignment**

except Activity2 and four projects. However, process work will be reflecting as student participation. Participation also includes contributing to small-group and whole-class critiques and attentiveness and respect towards the instructor and fellow classmates as well as attendance. **Late submission of Activity2 and four projects will not be accepted after the due date.**

ATTENDANCE POLICY

Attendance for in person class periods is determined by your physical presence. On student choice days, your attendance is taken by physical presence or by your turning in progress images by the end of the class period. Attendance is taken at the beginning of each in person class, and at the end of each student choice class. Students are expected to arrive at in person meetings on time and be prepared to participate in all activities. You will be considered tardy if you arrive after class begins.

Failure to submit a progress image on a student choice day counts as an unexcused absence. An unexcused absence does not constitute an extension of an assignment. If a student wishes to have an absence excused, they must provide the instructor with a written explanation of absence and/or appropriate verification when necessary (e.g., letter from doctor or parent) is required the class following the absence. Students must be present for the final critique in order to receive credit for their final project. Registered students who do not attend at least one of the first two class meetings for the course, and who have not contacted the department to indicate their intent, may be dropped from the course.

RECORDING POLICY

Sound or visual recordings may not be made during class time except in particular circumstances as defined by the university. These include the following:

- The recording is part of a class assignment.

faculty or lecturer during a class session. Publication without permission of the instructor is prohibited. To “publish” means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third-party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Code.
