This course is designed to provide learning opportunities in costume technology and portfolio pieces through realized work in the production season. Possible assignments include but are not limited to: Stitcher, First Hand, Draper, Tailor, Crafts Artisan, Makeup Artisan, and/or Wig Artisan.

Course Schedule

Timeline	Purpose of meeting
First week of the semester	Meet with Instructor of Record and Costume Shop Staff to finalize parameters of practicum assignment. Set weekly schedule expectations.
Second week of classes	Review addendum of syllabus for practicum assignment. Sign off on syllabus.
Ongoing throughout the semester	Work on practicum as assigned under the supervision of the Instructor and Costume Shop staff.
Completion of practicum assignment	Dependent on the parameters set at the beginning of the semester. See student's signed addendum.
