## COURSE OBJECTIVES

You will master a variety of techniques for inspiring improv scenes and learn a number of long-form structures that you will perform in teams. You will also participate in a public performance at the end of the semester.

## REQUIRED TEXTS

## EXPECTATIONS

In order to grow as a performer, I expect you to take risks in games, exercises, and teamwork. This class is a space where you respect, support, and encourage your fellow actors. Honesty in scene work will be celebrated as well as *playing at the top of your intelligence*, a key concept in improv which favors smart moves over stereotypes or low-brow humor for its own sake.

## ATTENDANCE POLICY

This is a class *about* participation – attendance is a given. **You are expected to arrive ON TIME and to attend ALL classes.** If you feel you cannot make this commitment, please drop the class. Since working live with others is the primary focus of the class, there is no way to make up missed class time. When you work in teams, missing class hurts your peers and supporting your team is an essential part of this work.

If you develop COVID-19 symptoms (persistent cough, fever 100.4+, new loss of taste or smell, muscle pain/headaches, shortness of breath, sore throat, chills, diarrhea, or feeling generally ill), *do not* come to class. The culture of hiding illness or the “show must go on” mentality must be avoided.

Any absence from class for the following reasons must be supported by official documentation to avoid a grade penalty:

- Serious family emergencies
- Special curricular requirements (e.g., judging trips, field trips, professional conferences)
- Military obligation
- Severe weather conditions

- Participation in official university activities such as music performances, athletic competition or debate
- Court-imposed legal obligations (e.g., jury duty or subpoena)

Religious observances do not require documentation. However, you need to let me know by the second week of classes which religious observances will conflict with your attendance.

**Students are allowed ONE unexcused absence that does not require documentation and does not conform to the UF “acceptable reasons for absence.”** Afterwards, each unexcused absence will result in a penalty of a full letter grade (10%) deducted from your final grade. Weddings, travel, job interviews, non-UF auditions, and other life events do not count as excused absences. If you have a logistical problem that will prevent you from arriving on time, see me immediately.

Any student that acquires THREE absences (either excused or unexcused) will be required to meet with me to discuss your continued participation in the course. For Majors: Failure to attend this meeting will result in Artistic Probation.
