#### PREREQUISITES FOR MVS 3431

For all music majors (but NOT minors), a Pre-Professional Jury for admittance to the 3000 level is required at the end of the 2nd semester of 2000-level study. A jury of 2 contrasting works must be prepared for a total playing time of 10 minutes; in addition, students must speak for 4 minutes about one of the pieces performed, and will be asked to sightread. Students must be passed by a majority of the faculty present. Minors will be accepted into MVS 3431 ONLY if they meet the technical standards of the typical repertoire listed below. Minors are required to have one semester of MVS 3431.

## **COURSE CONTENT**

The repertoire is greatly expanded at this level, and considerable experience in performance is stressed. A minimum of 3 Studio Class performances is required, and it is expected that students will perform in venues other than Studio Class. For the jury in the first semester of 3000-level study, 2 contrasting works for a total playing time of 15 minutes must be presented. For all majors other than the B.M. in Performance, the completion of 2 semesters of MVS 3431, along with the presentation of a junior recital, fulfills the curricular requirement for violin study. The recital program, given in the 2nd semester of 3431, must have program notes on the repertoire performed, must represent a diversity of styles and periods, and must include at least one memorized movement from the unaccompanied sonatas and partitas of Bach. The length of the program should not be less than 30 minutes. A jury is required 2 weeks before the recital, in front of all members of the student's committee. The entire program must be ready to be performed; the committee will listen, at its discretion, to 15 minutes of the program. The committee must include the student's professor, another faculty member from the String Area, and a faculty member from outside the String Area. For students continuing on to the 4000 level of study (which includes those seeking the Performer's Certificate) the successful presentation of the Junior Recital is required. Students must be passed by all members of their faculty committee, and the student will be notified as soon as the committee has conferred and reached an agreement. If all members of the committee are present at the recital, it should be that same evening; otherwise, the student must immediately provide a recording of the recital to any absent faculty.

## STUDIO POLICY FOR ALL LEVELS OF VIOLIN STUDY

Grades will be based on three separate factors, each carrying equal weight:

- 1) lesson attendance and preparation, especially etude completion, and general improvement;
- 2) studio class performances;
- 3) the final jury.

## 1. Attendance and Lesson Preparation:

Attendance at all lessons, studio classes, the professor's concerts, student recitals by members of the Violin Studio and special performances (you will be told about these ahead of time) is mandatory. An absence I don't know about at least 24 hours ahead of time is **UNEXCUSED**, and each unexcused absence automatically lowers your grade one whole letter grade for the attendance portion, as well as the lesson preparation portion (see below). It is almost impossible to receive an A if you are a

"no-show". In cases of serious illness or other emergency arising the day of the lesson, text me on my cell phone <u>as well as</u> try to reach me at my office. Absence due to illness must be verified by a doctor's excuse. Always try to call/text me on my cell phone first, anytime between 8 AM and 10 PM. **Email will not cover you, so do NOT email without also texting me that you will be missing a lesson.**

Students are required to monitor their ufl.edu email accounts daily for receipt of communications, announcements, etc. from the professor.

If you come to a lesson unprepared, it will be clear you have not practiced between lessons (which is doing the "homework") and you will receive an F for that lesson. Marked improvement <u>must</u> be demonstrated in the next lesson. (Each unexcused absence lowers your grade one whole letter grade in this category as well.) Etudes are expected to be completed and perfected within 1 week. If you take too long to perfect your etudes, that alone will lower this 33% of your final grade. In addition, you must be able to talk about everything you are studying; you should know: composer's dates, brief biographical sketch, form of each movement, musical definitions, etc. You are not being judged by how advanced you are, but by the effort you put into your assignments, regardless of your ability. If you practice carefully, and do your assignments, you will improve, which is essential to moving on to the next level of study. Those starting at MVS1411 must reach the standards of 2421 by the end of the first year; likewise, those studying at the 2421 level must meet the requirements of 3431 before they can move on. All music majors must pass the Pre-Professional Jury before they can be registered for 3431; registration for 4441 is upon successful presentation of the Junior Recital, and is determined by the recital committee of 3 faculty members.

#### 2. Studio Class Performances

Performances in studio class are required of all repertoire studied, (except etudes) and will be graded. Works with piano accompaniment must be performed with accompaniment, and heard in a lesson prior to the class. Undergraduates at the 1000 and 2000 level must perform a minimum of two times per semester; 3000, 4000 and graduate students must perform a minimum of three. The grades will be averaged together to achieve this portion of your grade. It is in your best interest to perform as often as possible.

## 3. Final Jury:

You will be graded and critiqued by the string faculty at the end of the semester. All those registered at the 1000 and 2000 level need to prepare at least one work for a total of 10 minutes; those registered at the 3000, 4000, and graduate levels must play 2 contrasting works, for a total playing time of 15 minutes. Once a work has been performed for a jury, it may never be repeated in another. All works with piano accompaniment must be performed with a pianist; securing a pianist and getting him/her to show up on time for the jury is your responsibility. Your jury grade will be lowered one whole letter grade if you play without piano accompaniment, or if you are late. The grades assigned by each faculty member will be averaged together to arrive at this portion of your grade. If you do not show up, or you are unable to take the jury, you will receive an Incomplete for the semester; a jury will be held as early as possible in the succeeding semester, and the Incomplete removed. The day of the jury will be announced as soon as it is finalized.

# **COVID19 ADDENDUM**

This addendum outlines protocols to ensure safe instruction for all in the violin studio. The situation, and safety protocols, continue to evolve. You will be informed as changes occur; protocols may be relaxed as the semester progresses – and infections fall - or the opposite could happen. However, if you have not tested positive, experienced symptoms, or been exposed to someone who tested positive, we are fortunate that we can have live, in person lessons, for which the following requirements MAY be requested:

- 1. Students may be requested to wear a mask, and may wear a mask if their comfort level requires it. If so, bandannas, face guards, kerchiefs, gaiters, etc., are NOT acceptable face coverings. Students must procure masks that cover both nose and mouth, and masks should be N95 or KN95.
- 2. Distancing of 6-7 feet is not required as of this writing, but may be re-instated at any time.
- 3. Students must affirm before entering the studio that they have taken their temperature and it is in the normal range, and that they are not experiencing any other symptoms that could be related to the virus (sore throat, cough, shortness of breath, loss of smell or taste, etc.)

It is noted that at any moment the university – or Dr. Lower - may alter the protocols or suspend in-person instruction, at which time lessons will continue remotely through either Skype, Zoom, prepared videos, or whatever mechanism works best given limitations each student may have for WiFi, etc.
