Course Description: This course will examine the current state of research in the field of Colonial Latin American Art History. The field is comprised of scholarship on the art and culture of the Spanish viceroyalties, spanning the period between the European invasion of the hemisphere in 1492 and the wars of independence in the early 19th century. The goal of the course is to read recent scholarship (often paired with canonical books, chapters, articles) on many of the most important topics in the field. This approach will expose students to a variety of the most important scholars and help them learn about the key methodological approaches that they have adopted in their research. It will also help them identify and understand the main issues and ideas that anchor the field, many of which also provide points of connection to other, related fields within the discipline of art history.

Required Reading: There are no required textbooks for the course. Instead, we will use numerous book chapters and articles available on our Canvas page.

You will need to write on, make notes in and underlines these texts so that we can return to them in discussion. So, whether you print the readings or use your screens is up to you, but you will need to be able to bring them to class so please plan accordingly.

20% Attendance & Participation

10% Discussion Leadership

25% Weekly Reading Prep

Attendance and Participation: Attendance is extremely important in a seminar style class, as many of our learning outcomes can only be achieved by attending class and participating fully in discussion. As a result, attendance and participation will make up a large portion of your final grade for the class (20%). You will be allowed *one* un-

penalized absence, which assumes that you will need a day because you are sick, etc. For each subsequent absence you will lose 2 points from the "Attendance and Participation" portion of your final grade. (Obviously, absences due to poor health will be excused, although you should note that excessive absences may result in a failing grade).

With regards to participation, it is important that you come to class having read the material, and then *engage* in class discussion in a meaningful, collegial, and constructive way. Failure to come prepared, or to engage with the class conversation in ways that reflects your preparedness, will result in a loss of credit for that day's participation. I realize that participating in class discussion will come easier for some than others; we all must be aware that some students will need to step *up* and speak, and others must step *back* and make space for the opinions of others.

Each day, before class concludes I will ask all students to complete and turn in a small slip of paper that offers a self-assessment of their level of preparedness and participation. This exercise will ensure that students have the chance to reflect on a weekly basis on the way that they are showing up in class and to make changes if necessary. It will also provide a touchstone for my own assessment (a weekly participation grade) that will reflect the degree to which students contribute to the classroom dialog in a positive fashion.

Discussion Leadership: For each week, a single person will take charge of leading the discussion of that material, which will help us interrogate and better understand the assigned reading(s) and their connection to bigger issues. You will sign up in week 2 for the week you will lead.

Weekly Reading Preparation: Each week you will be required to complete a writing assignment about the assigned reading. This will often, but not always, take the shape of a one-page summary of the reading that encapsulates its main argument. These assignments must be turned in by **9am on the day of class.** I will circulate some of these writings (without names attached) in class to use them as points of departure for our discussion about the readings. The in-class discussion of the summaries will not only help us consider various "readings" of the reading, but it will also allow us the chance to critique them as written documents, helping us hone our craft as writers.

Final Research Presentation/ Paper Assignment: Instead of exams, you will write an in-depth research paper on a topic related to the class. The goal of this research paper is to select an issue of interest and explore it in much greater depth than is possible in class. You should collect scholarly sources, read them, synthesize their arguments, examine the artworks/objects for yourself, and compose a thoughtful essay that makes an *argument* about the artworks or concepts that made up the focus of your examination. Your papers should be 15-20 pages in length (2x spaced, times new roman, normal margins), not including a title page, images, and the bibliography.
